

# Limited Warranty

The JBL warranty on loudspeaker products remains in effect for five years from the date of original purchase. Moreover, because we believe that a fine loudspeaker should never wear out, we may, at our option, choose to repair any JBL transducer free of charge after the five year period. All other JBL products are warranted for two years from the date of original purchase.

## Who Is Protected by This Warranty?

Your JBL warranty protects the original owner and all subsequent owners. Simply present the original bill of sale if warranty service is required.

## What is Covered by the JBL Warranty?

Your JBL warranty covers all defects in material and workmanship. For your information, here is a list of the conditions that are not covered: damage caused by accident, unreasonable use or neglect; damage occurring during shipment (claims must be presented to the carrier); damage resulting from failure to follow instructions contained in your Instruction Manual; damage resulting from the performance of repairs by someone not authorized by JBL; JBL products which have had their serial numbers effaced or removed.

## How to Obtain Warranty Performance

If your JBL product ever needs service, simply return it to the JBL dealer from whom it was purchased. He will arrange for necessary repairs. If for some reason this is impractical, please write to us at James B. Lansing Sound, Inc., (ATTN: Customer Service Department), 8500 Balboa Boulevard, Northridge, California 91329, (213) 893-8411. We may direct you to an Authorized Servicing Dealer, should this be more convenient for you, or ask you to send your

unit to the factory for repair, in which case we'll also supply complete shipping instructions. Either way, you'll need to show the original bill of sale to establish the date of purchase. Please do not ship your JBL product to the Northridge address without our authorization.

## Who Pays for What?

JBL will be happy to pay all labor and material expenses for all repairs covered by its warranty. Although you must pay any shipping charges incurred in getting your JBL product to a JBL Authorized Servicing Dealer or to the JBL factory, we will pay return shipping charges if the repairs are covered by the warranty. Please be sure to save the original shipping cartons because a nominal charge will be made for additional cartons.

## EXCLUSION OF CERTAIN DAMAGES

JBL'S LIABILITY IS LIMITED TO THE REPAIR OR REPLACEMENT, AT OUR OPTION, OF ANY DEFECTIVE PRODUCT AND SHALL IN NO EVENT INCLUDE INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND. SOME STATES DO NOT ALLOW THE EXCLUSION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE EXCLUSIONS MAY NOT APPLY TO YOU.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

We sincerely thank you for your expression of confidence in JBL products. The unit you have just purchased has been painstakingly assembled in our own facilities by highly trained craftsmen. It should give you many years of musical enjoyment.

This warranty applies to covered JBL products manufactured after December 31, 1976, and supersedes all previous warranty statements.
